- 2) The filled-up forms will be received at the school office from Monday to Friday (9.00 am to 11.30 am and 1.30 pm to 3.30 pm).
- 3) The application (registration) does not, in any way, entitle the candidate to be admitted to school.
- 4) **Admission will be through Draw of Lots for all categories if the number of applicants is more than the seats available.**
- 5) Date and time for mandatory Parents interaction will be notified on 19/11/2025.
- 6) **Documents required for registration:**
 - i) For IOCL candidates, Certification by IIR department. (Provision for the same is available in the form itself)
 - ii) For CISF BGR unit, Certification is required from competent authority of the same unit.
 - iii) Registration form should be duly filled up in **capital letters** along with passport sized photograph pasted (not stapled) on the form.
 - iv) A photocopy of the birth certificate of the candidate.
 - v) Proof of residence.
